as a manufacturer of packaging and technical molded parts of all kinds made of EPP, we are a downstream user (manufacturer of products) according to the REACH regulation. According to information from our suppliers, the materials we use do not contain any substances of concern (SVHC) of Annex XIV of the REACH Regulation (Regulation (EC) No. 1907/2006) in accordance with Article 57 version 17 of February 4, 2026 above 0.1%. Should a new candidate substance be contained in the products that we deliver to you in the future, we will comply with our legal information obligation according to Art. 57 REACH without being asked.

according to Annex II of Directive 2015/863/EU (RoHS 3), or according to Article 6 of Directive 2011/65/EU (RoHS 2) and Regulation (EC) No. 850/2004 of the European Parliament and Council of 29 April 2004 on persistent organic pollutants and amending Directive 79/117/EEC (OJ EU L 158 of April 30, 2004, p. 7), last amended by Regulation (EU) 2022/1021 of November 23, 2022 amending the Annexes IV and V of the regulation, are not exceeded limits. Because we don't add any additives to the raw material during production and none of the substances mentioned are released in the production process, we can confirm that the products we deliver to you comply with the substance bans in accordance with the above-mentioned guidelines and limit values are not exceeded.

This declaration applies only to articles made of EPP without inserts or any additional attached parts.

### Declaration of Conformity – PFAS

Per- and polyfluoroalkyl substances (PFAS) are a large class of thousands of synthetic chemicals used throughout society. However, they are increasingly being discovered as environmental pollutants, and some are associated with adverse effects on human health.

JSP carefully monitors regulations related to restricted substances, whether set by OEMs or regulatory bodies.

For 10 years, PFAS (polyfluoroalkyl substances) have been a cause for concern worldwide due to their toxicity and persistence in nature.

For this reason, PFAS have been included in lists of regulated substances for more than 10 years, e.g., in the POP, REACH, and even REACH-SVHC regulations. However, it should be noted that more than 2,000 PFAS substances are registered on the EU market alone. Due to this very high number of substances, only the PFAS groups of particular concern are currently listed in the regulations.

We are pleased to confirm that we do not use any of the PFAS listed in POP (EU) N0 2019/1021, REACH, or REACH-SVHC regulations in the manufacture of ARPRO. For all grades that are GADSL-compliant, we can also assure you that no PFAS need to be declared in our formulations.
